## Council Items-

---

The meeting was called to order by Matt Jacobson at 4:32 p.m.

1. Approval of the Agenda- The agenda was reviewed and a motion was made to approve the agenda by Chris Nethery and seconded by Snehal Chauhan. All were in consensus of approval of the agenda.
2. Approval of Minutes – The Council reviewed the October 26th Draft Minutes. Kym Wright made a motion to approve the minutes and Matt Brown seconded the motion. The October minutes were approved by consensus.
3. Council Action Items:

i). Review and 2nd reading of policy 9002 – Parent and Family Engagement Policy: Mr. Jacobson reminded the Council that any new policy must first be read by the SBDM Council and then at this Council meeting the Council would review the policy a final time and then approve it to become a new policy. Kim Wright made a motion to approve policy 9002. Chris Nethery seconded the motion and all approved by consensus.

ii). Approve Revised Policies (4000 Series) The Council reviewed revised policies 4002, 4003, 4004. Jessica Baldwin made a motion to approve the revised policies. Kym Wright seconded the motion and all approved by consensus.

iii). Review SBDM Policies (2001, 2002, 2003) The Council reviewed 2001 and under section B.) Committee Review - The Council wanted to change the policy to read “ two staff members (school or district) whose academic department is affected...” instead of “two staff members whose subject area is affected...” The Council reviewed 2002 and there were questions regarding how the adoption cycle works and who regulates and enforces the standards. The Council decided they would revisit the 2002 policy after Mr. Jacobson has a chance to do some research on the adoption cycle. The Council reviewed 2003 and there weren't any changes made.

iv). Items for Next Month include approval of the CSIP, closing the Achievement Gap Diagnostic, Executive Summary for Schools and PD plan for school.

Principal Update – Back to NTI. Mr. Jacobson gave the Council an overview of where we are with NTI at the moment and he discussed the schedule change.

Consultation on Personnel Actions. There were no personnel issues to discuss so the Council did not go into closed session.

General Public Concerns: None at this time.

Motion to adjourn was made by Kym Wright and seconded by Matt Brown at 5:14 p.m. and agreed by consensus.
