The Oldham County Middle School Council met in regular session at Oldham County Middle School in Buckner, Kentucky on Monday, December 14, 2020.

In Attendance

Council Items-

The meeting was called to order by Matt Jacobson at 4:34 p.m.

1. Approval of the Agenda- The agenda was reviewed and a motion was made to approve the agenda by Chris Nethery and seconded by Jessica Baldwin. All were in consensus of approval of the agenda.

A motion was made by Kim Wright and seconded by Chris Nethery to approve the PD draft as written. All were in consensus for approval of all three.

The Council further discussed the CSIP and then Jessica Baldwin made a motion to approve the CSIP which was seconded by Kim Wright and the Council agreed by consensus.

iii). Items for Next Month – Review of Policy 9004.
