We have clustered ELL kids with certain teachers. Certain teachers have met with Alec Johnson and they worked on EL strategies for classroom help to share with other teachers. IEPs/Minority Groups; EL Groups / Free & Reduced Groups are all receiving support and help through their Intervention Teachers. OCMS math resource students get both a class and resource.
 - iii. Tell Survey – Mrs. Baldwin will be getting the information over Fall break. The SBDM Council will be reviewing the working condition survey done by employees as information goes into the Needs Assessment Goals.
